Dear Mr. Shapiro and Mr. Garfield:

Electronic waste is the fastest growing part of the waste stream, but it poses special problems for local solid waste management programs. Electronic products contain a variety of materials that are recoverable and recyclable, but some of the materials are potentially hazardous if not managed properly. Increasingly, local governments are expected to spend more and more of our limited taxpayer/-ratepayer dollars managing this growing problem.

We the undersigned are state and local government officials from states which have already enacted or hope to adopt e-waste recycling laws that give the electronics manufacturers responsibility for financing effective takeback services for all the products they are selling in our states. We support producer responsibility laws for electronics because we understand that the manufacturers will internalize the cost of running such programs into the product price which is a more equitable means of providing this service. In addition, we are hopeful that these policies will lead to products designed to be less toxic and more recyclable.

Voluntary Takeback Programs Not Performing

Many electronics manufacturers either do not offer national takeback programs or they operate voluntary programs that do not result in significant recycling volumes. To fill this gap, states and local governments have adopted producer takeback laws in eighteen states and New York City. Some of these programs are already operational and are generating significant recycling volumes – far higher rates than voluntary programs. In these states, the manufacturers are already running effective programs. In Washington State for example, over 29 million pounds of electronic products have been collected in the first nine months of that State's manufacturer responsibility program.

In some cases, member companies of your organizations helped enact the laws that resulted in successful state programs. And in states with legislated programs, we have appreciated the cooperation and efforts by the manufacturers in getting these programs launched and underway. It concerns us that your organization is now challenging the very concept of producer responsibility that many of your members have publicly supported.

New York Lawsuit Challenges State and Local Rights, and Harms Taxpayers

Despite your member companies' public support for the producer responsibility concept, your respective trade associations have taken the alarming step of filing a lawsuit against the New York City law implementing producer responsibility. As such, your actions are a direct challenge

to state and local government efforts to protect public health and the environment. Governments can little afford to cover the recycling or disposal costs of each product brought to market. In bringing forth this lawsuit, we believe the industry is not meeting its fiscal responsibility and shifting it to taxpayers/ratepayers. In this respect, and given that some of your members have publicly supported producer responsibility, we feel you are out of step with the policy direction clearly emerging in the US, and one that already exists in much of the developed world.

We call on your organizations and your members to withdraw your lawsuit in New York City.
